

**TURN IT ON DESIGNS, LLC**  
**CUSTOMER AGREEMENT**

**NOTICE TO CUSTOMER: THIS IS A LEGALLY BINDING BETWEEN YOU (THE “CUSTOMER”) AND TURN IT ON DESIGNS, LLC (“TURN IT ON DESIGNS”). IT IS IMPORTANT THAT YOU CAREFULLY READ THIS AGREEMENT BEFORE SUBMITTING ANY PHOTOGRAPHS, DESIGNS, ARTWORK, OR OTHER ITEMS TO TURN IT ON DESIGNS (“SUPPLIED ITEMS”).**

1. **Grant Of Rights To Turn It On Designs:** Customer hereby consents to the use of the Supplied Items by Turn It On Designs and agrees to perpetually license and grant to Turn It On Designs the rights to reproduce the Supplied Items and to prepare derivative works of the Supplied Items without restriction. Customer agrees to indemnify and hold Turn It On Designs harmless from any claims pertaining to said Supplied Items including, but not limited to, any claims of infringement of Customer’s copyright rights in the Supplied Items and to indemnify and hold Turn It On Designs harmless against any claims pertaining to said Supplied Items including, but not limited to any claims of copyright or trademark infringement by any third parties. Customer acknowledges that the Supplied Items may not be returned to Customer by Turn It On Designs.

2. **Miscellaneous Governing Terms:** This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective legatees, representatives, successors, and assigns. This Agreement shall be construed and interpreted in accordance with the laws of the State of Minnesota. Each of the parties hereto agrees to execute and deliver such other, further and different instruments as may be appropriate or necessary to effectuate the intent and purposes of this Agreement. Terms shall have the meanings set forth in this Agreement, and where said meanings are intended, said terms shall be capitalized. All of the provisions of this Agreement are separable, so if any provision of this Agreement is held to be ineffective by a court of competent jurisdiction, the remaining provisions of this Agreement shall remain in full force and effect unless the invalidated provision is so fundamental to this Agreement that the remaining provisions do not reflect the parties' intent. You affirm that you are fully authorized by your respective corporation or other business entity, if any, to affirm this Agreement and to thereby bind your respective corporation or business entity. This Agreement contains the entire agreement of the parties hereto with respect to the subject matter hereof and supersedes any and all prior agreements and understanding between the parties with respect to the same. This Agreement may be modified only by a written instrument executed by both parties.
